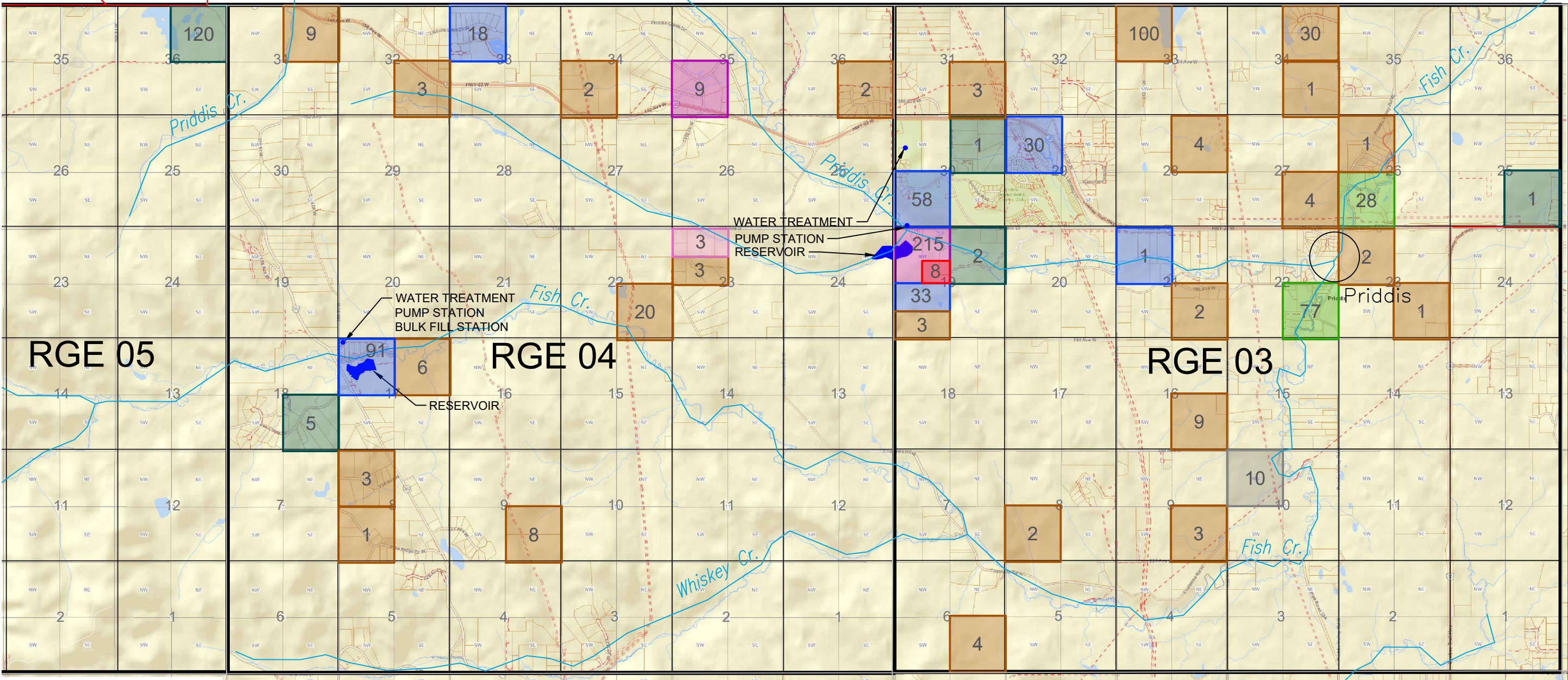


SURFACE WATER LICENSE POINT OF DIVERSION MAP (waterlicenses.alberta.ca) 2024-04-12
